Thomas, 584 S.W.2d 15, 18 (Mo.App.1979). To establish prejudice, the appellant must show a reasonable probability of a different result at the new trial, where the evidence would be the same as the evidence at the first trial. State v. Pettis, 712 S.W.2d 298, 301 (Mo.App.1986). In addition, the State may not be required to do the impossible. State v. Edwards, 759 S.W.2d 935, 937 (Mo.App.1988). Here the appellant entered two pleas of guilty. The appellant testified at the motion hearing and stated that at the time he entered the pleas he had been taking certain drugs on a daily basis.
